

Equities Market Defies Bearish Sentiment, Gains by 0.85%; Naira Weakens, Slips ₦1,533.99 Against Dollar in Official Market....

In Thursday's trading session, the equities market displayed resilience, with the All-Share Index ascending by 84 basis points to reach 98,156.71 points. Despite encountering resistance from bearish sentiment, marked by 24 declining stocks compared to 15 advancing ones, the market exhibited an overall positive trajectory. Consequently, the market capitalization of listed equities surged by 0.85% to reach N55.53 trillion, translating to a collective investor gain of N466.73 billion. This upward momentum was primarily fueled by notable performances in key stocks such as GUINEAINS, ROYALEX, AIRTELAFRI, INTENEGINS, and PRESTIGE, which recorded impressive share price gains of +10.00%, +10.00%, +8.47%, +7.84%, and +5.88%, respectively. These stocks played pivotal roles in driving today's market rally. Trading activity on the Nigerian Exchange Group (NGX) witnessed an uptick, with total traded volume and value increasing by 15.25% and 24.95%, respectively, reaching 409.77 million units and N8.93 billion. However, the total number of deals for the day saw a marginal decline of 0.50% to 7,296 trades. Despite the overall positive sentiment, sectoral performance remained downbeat, with four out of the five sub-indices tracked closing in the red. The Banking, Consumer Goods, Oil/Gas, and Industrial Goods sectors experienced losses of 3.04%, 0.06%, 0.36%, and 0.002%, respectively, while the Insurance sector saw a modest increase of 0.51%. CUSTODIAN emerged as the most traded security by volume, with 115.58 million units exchanged in 68 trades, while

AIRTELAFRI led in traded value, totaling N2.17 billion.





Money Market

In the money market, the Overnight NIBOR increased by 0.13% to reach 30.93% due to tightening liquidity conditions. Short-term benchmark rates such as the open repo rate (OPR) and overnight lending rate (OVN), declined by 1.01% and 1.19% to settle at 29.86% and 30.65%, respectively.

NITTY traded lower across tenor buckets. As a result, the average secondary market yield for Nigerian Treasury Bills decreased by 0.01% to close at 21.39%.

Bond Market

In the secondary market for FGN Bonds, the average yield closed at 18.68%.

In the sovereign Eurobonds market, buy-interest was evident across all segments of the yield curve, resulting in a decline in the average yield by 0.13% to 9.64%.

Foreign Exchange Market

In the foreign exchange market, the Naira faced pressure as it depreciated against the dollar by 5.14% to close at \(\mathbb{N}\)1,533.99 per dollar in the official market. Meanwhile, in the parallel market, the Naira closed at \(\mathbb{N}\)1,515 against the US dollar.

Global Commodity Market

At 3:30 p.m. GMT+1, oil prices saw an increase as Brent crude rose by 0.28% to \$82.98 per barrel, while West Texas Intermediate (WTI) crude also increased by 0.45% to \$78.99 per barrel.
