
Local Bourse Displays Resilience as ASI Edges up by 0.03%; NIBOR Falls for All Tenor Buckets amid Liquidity Boost....

Thursday's trading session witnessed a subtle yet encouraging uptick in the All-Share Index, edging up by 0.03% to 98,255.72 points. Correspondingly, the market capitalization of listed equities followed suit, advancing by the same margin to close at N55.57 trillion, marking a total market gain of N17.96 billion. Bullish momentum echoed throughout trading activities, with remarkable surges across key metrics: total deals, volume, and value escalated by 3.62%, 111.99%, and 81.56%, respectively, totaling 8,415 deals, 676.42 million units, and N16.66 billion. Sectoral performance reflected a positive trajectory, with gains observed in the Banking, Insurance, and Industrial Goods indices, rising by 1.06%, 0.47%, and 0.04%, respectively. However, the Consumer Goods sector experienced a marginal setback of 0.54%, while the Oil/Gas sector exhibited subdued performance. Among individual stocks, standout performers included LEARNAFRCA (+10.00%), TANTALIZER (+7.69%), MBENEFIT (+5.45%), GTCO (+5.26%), and OANDO (+4.90%), showcasing robust share price gains. Conversely, PZ, SOVRENINS, HONEYFLOUR, AFRIPRUD, and JAIZBANK endured share price losses of -9.94%, -9.52%, -8.23%, -5.84%, and -5.00%, respectively. Notably, NB emerged as the day's most traded security in terms of both volume and value, with 300.36 million units valued at N6.91 billion, exchanged in 349 trades, closely followed by UBA.



Money Market

In the money market, NIBOR rates saw a downward trend across tenor buckets, even as the overnight NIBOR decreased by 1.00% points to settle at 28.58%. Consequently, key money market rates such as the open repo rate (OPR) and overnight lending rate (OVN), nosedived to conclude at 28.22% and 28.97%, respectively.

NITTY traded lower for all tenor buckets tracked due to demand pressure. Likewise, the average secondary market yield on Nigerian Treasury Bills cleared lower by a base point, to close at 21.64%.

Bond Market

In the secondary market for FGN Bonds, there was low level of activity, as yields were flat for most maturities across the curve. However, the average yield expanded by 3-basis points to close at 18.61%.

In the sovereign Eurobonds market, negative sentiment prevailed, causing a 1-base point increase in the average yield to 9.69%.

Foreign Exchange Market

In the foreign exchange market, the Naira depreciated against the dollar by 2.72% to close at ₦1,459.73 per dollar in the official market. In the parallel market, the Naira closed at ₦1,418 against the US dollar

Global Commodity Market

At 3:30 p.m. GMT+1, Oil prices experienced an increase, with the Brent crude rising by 0.37% to trade at \$83.89 per barrel, and the West Texas Intermediate (WTI) crude oil also increasing by 0.54% to trade at \$79.41 per barrel
